Section 137 of the Health Practitioner Regulation National Law (the National Law)

This form is to give notice of the surrender of your general and/or nonpractising registration as an enrolled nurse, registered nurse or midwife.

Under section 137 of the National Law, a registered health practitioner may, by written notice given to the National Board that registered the practitioner, surrender their registration. The surrender of the registration will take effect from the day the Nursing and Midwifery Board of Australia (the NMBA) receives this notice, or the later day stated in this notice. **No refunds apply**.
