

# Communiqué

Meeting of the Nursing and Midwifery Board of Australia held on 28 July 2016 at the AHPRA National Office, Melbourne.

The Nursing and Midwifery Board of Australia (the National Board or NMBA) is the national regulator for nursing and midwifery in Australia. It is established under the Health Practitioner Regulation National Law, as in force in each state and territory (the National Law).

The NMBA meets monthly and considers a range of matters, the most important of which are published in this Communiqué.

#### Chair of AHPRA's Agency Management Committee attendance at NMBA meeting

The Chair of AHPRA's Agency Management Committee, Mr Michael Gorton, provided an update to the NMBA on the Committee's priorities.

Mr Gorton acknowledged the NMBA's engagement with nurses and midwives through its information forums around the country, as well as the importance of the new national health support service to be launched in 2017.

#### Midwifery expert advisory group for standards for practice project

A midwifery expert advisory group has been established to provide advice and guidance to Deakin University and the NMBA on the drafting of the *Midwife standards for practice*.

There will be an opportunity for midwives to provide feedback on the draft standards during the public consultation phase of the project planned for early 2017.

#### **Information forums**

The NMBA continues to engage directly with nurses and midwives at information forums around the country.

In July, the NMBA visited Brisbane, Gold Coast and Adelaide and discussed registration changes in person with over 350 nurses and midwives, as well as videoconferencing with Queensland Health sites.

The NMBA will continue to host information forums nationally throughout 2016. Nurses and midwives will receive an invitation via email if a forum is scheduled near their place of work.

- managing notifications about the health, performance and conduct of registered health practitioners and offences against the National Law, and

monitoring health practitioners and students with restrictions on their registration.
