Snapshot – registered health professions, 2010 until now

- AHPRA supports the <u>15 National Boards</u> that are responsible for regulating the health professions under the National Scheme.
- The National Boards register health practitioners, set the requirements for registration and the standards that guide professional practice, make decisions on complaints about registered health practitioners, oversee accreditation of education providers and programs of study, and assess overseas-qualified practitioners for registration in Australia.
- The Northern Territory has seen the largest growth in the number of health practitioners between 30 June 2011 and 14 May 2018, increasing 45 per cent to 7,425, New South Wales has the highest number of registered practitioners, with 202,351 (increasing 30 per cent).
- Registered practitioners aged 30-34 are the largest age group, with 100,542 practitioners, increasing 70 per cent during the period. There are 91,891 practitioners aged 25-29 (increasing 58 per cent).
- There are far more female practitioners than male, at almost 76 per cent compared to slightly more than 24 per cent of male practitioners. A very small number of practitioners identify as intersex or indeterminate. Among the individual professions, there has been a significant rise in the number of female dentists, rising from 40 to 51 per cent of all dental practitioners, with the proportion of female medical practitioners rising from 38 to 43 per cent.
- Nurses comprise the largest single group of registered practitioners, with a total of 396,765 registered
 as either a nurse or holding dual registration as a nurse and midwife. This is an increase of 17% over
 the period.
- Medical practitioners are the next largest group with a total of 114,874, increasing 30 per cent during the period.
- There has been a 108 per cent increase in the number of registered Aboriginal and Torres Strait Islander Health Practitioners.
- The number of registered osteopaths has risen 50 per cent to 2,385, with a 49 per cent increase in registered podiatry practitioners, at 5,149.
- The number of registered physiotherapists has risen 43 per cent to 31,889.
